In light of the recent California wildfires, a resident presented questions to the board and they are listed below:

- **Q**: What is the flow capacity of our hydrants? **A**: The flow capacity of our hydrants are, at a minimum, the WA State required flowrate of 1,000 Gallons Per Minute (GPM) for 60 minutes. We know this because they were tested by the Duvall Fire Department at least twice since we replaced the water distribution line back in 2015.
- Q: Is it enough to cover all homes at Lk Margaret? A: The above mentioned test performed by the Duvall FD proves that it SHOULD meet the requirements to put out a fully-engulfed home, and this is their metric to approving a fire hydrant. However, the question as asked could be interpreted as "can we provide enough water to put out fires at all homes on Lake Margaret". The short answer here is no. Our new water tank capacity is 132,000 gallons maximum, and that would be enough to put out two fully engulfed home fires, per the above mentioned metric. Then, after those fires are out, the water system would need to have about 20 hours to refill the tank from the well before we could provide another 60,000 gallons. Refilling our water tank from the lake via the treatment would be slower than the well.
- **Q**: Are the hydrants served by LMCPC water? **A**: Yes, all of the hydrants at Lake Margaret are served by LMCPC finished water in the new water tank.
- Q: Is it possible the hydrants could run out of water like LA? A: During the recent wildfire event in Southern California, the hydrants ran out of water for a multitude of reasons. Our situation here at Lake Margaret is significantly different than there, and we have many other options, including having the Duvall FD pump water directly from the lake to fight fires. From a capacity perspective, using the 60,000 gallon metric above for putting out a fully engulfed home fire, the lake itself would have far more capacity than needed to put out a fire at every home on Lake Margaret.
- **Q**: How often are the hydrants tested, and by whom? **A:** The fire hydrants are tested by the Duvall FD at a frequency defined by the Duvall FD.
- Q: It may be a good idea to have the fire chief to one of our meetings to get into more detail. A: The LMCPC Executive Board can ask the fire chief to attend one of our meetings, but we cannot guarantee that will happen, or how soon it could happen, but we will reach out to ask for their attendance.





During COVID-19 LMCPC recognized the need for leniency and grace periods on all utility bills much like the rest of the state's public utilities. At that time the board asked residents to make attempts to remain in communication and make partial payments in good faith with the agreement that the LMCPC would not enforce the bylaws of our community and begin the process of disconnecting utilities. Our community water re-

source is maintained and operated by the funds collected from our community, and as we fall behind and properties become past due, it becomes harder to maintain a 'good standing' with our community finances. Moving forward in the months of February and March, the board will begin making attempts to contact those who are delinquent on their bills to make arrangements to get current. For lots that fail to make contact and bills are left without payment plans, the LMCPC will move forward with the process set forth in our bylaws to make contact, set up payment plans, and if left without a response, utility disconnect and property liens will be enforced. We appreciate everyone's patience during the last 5 years as we have upgraded and made capital improvements to our water system to keep our water flowing. Many thanks to those volunteers in the community who have donated their time to keep the properties of the LMCPC in pristine shape. Please reach out to the board if you have a past due balance; LMCPC is specifically assessing and moving forward with lots that are 60+ days overdue. Thank you for your understanding.
