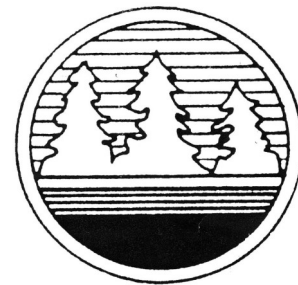

A Message from our president, Jason Battles:



There is still a burn ban for King County. PLEASE be a good neighbor if you are going to burn outside. It is always illegal to smoke out your neighbor. If smoke from your fire bothers your neighbors, damages their property or otherwise causes a nuisance, you must immediately put it out. Here are some guidelines to follow:

- Fires must not exceed three feet in diameter or two feet in height.
- Only charcoal, dried firewood or manufactured firelogs may be used. It is illegal to burn anything else.
- Stay clear of structures. Check with your local fire department regarding setback requirements.
- A person capable of extinguishing the fire must attend it at all times, and the fire must be extinguished before leaving it.
- Permission from a landowner, or owner's designated representative, must be obtained before starting a recreational fire.
- Recreational fires are always prohibited during air-quality burn bans. They may also be prohibited during a fire-safety burn ban (check with your local fire district.)

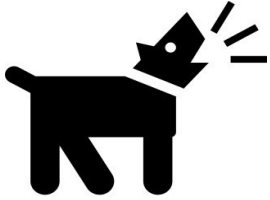
